

# Terms & Conditions – Over My Dead Body Murder Mystery Events

By booking, hosting, or participating in an Over My Dead Body (OMDB) Murder Mystery event, you acknowledge and agree to the following Terms & Conditions.

## 1. Participation at Own Risk

Participation in OMDB events is voluntary and at the participant's own risk. While every reasonable effort is made to ensure the safety, comfort, and enjoyment of all attendees, OMDB and its facilitators accept no liability for injury, illness, allergic reactions, or other adverse effects that may occur during or after the event, except where required by law.

## 2. Nature of the Event

OMDB events are immersive, interactive entertainment experiences which may include role-play, themed props, light movement, and audience participation. All elements are intended purely for entertainment purposes. Participants must follow the instructions of the host or facilitator at all times and use props or materials only as directed.

## 3. Personal Property and Clothing

OMDB is not responsible for any loss, damage, or staining to clothing, accessories, personal belongings, or property that may occur during participation in the event. Participants are advised to wear suitable clothing for an interactive event environment.

## 4. Behaviour and Conduct

Participants are expected to behave respectfully toward facilitators, venue staff, and other guests. OMDB reserves the right to remove or refuse participation to any individual whose behaviour is disruptive, unsafe, abusive, or inappropriate. In such cases, no refund or compensation will be provided.

## 5. Responsibility for Minors

OMDB events are primarily designed for adults. Where minors are present, they must be supervised at all times by a parent or legal guardian. OMDB facilitators are not responsible for supervising children or minors.

## 6. Venue Responsibilities

Where the client is responsible for arranging the venue, the client must ensure the venue is suitable, safe, and appropriate for the event, including providing adequate indoor shelter where required. If adverse weather conditions, venue safety issues, or circumstances beyond OMDB's control prevent the safe continuation of the event, OMDB reserves the right to modify or terminate the event at the facilitator's discretion. Refunds or rescheduling in such cases will be considered only where agreed in writing.

## 7. Damage to Props and Equipment

The booking client agrees to be responsible for any loss, theft, or damage to props, costumes, or equipment caused by attendees, guests, or pets during the event. The client may be charged for repair or replacement where damage occurs.

## 8. Health, Allergies, and Sensitivities

Participants are responsible for informing the host or facilitator of any allergies, sensitivities, or medical conditions that could reasonably affect their participation. Participants should not consume, apply, or otherwise use any materials or props unless explicitly indicated as safe for such use.

## 9. Limitation of Liability

To the fullest extent permitted by law, OMDB and its facilitators shall not be liable for indirect, incidental, or consequential losses arising from participation in the event. Nothing in these Terms excludes liability for death or personal injury caused by negligence where such exclusion would be unlawful.
